Leak Detection & Unaccounted for Water - Eric Denslow, Eastcom Associates

This session will begin with some classroom time, showing different types of equipment used for tapping machines. We will review tapping materials used for Saddles and the brass valves used for the service connections. Then we will do some acutal live taps on pressurized water pipes.

Master Meter Calibration, with Demonstration - Ian Kasowitz & Eric Kasowitz, Stiles Company

This session will cover the latest updates with water meter offerings and meter reading systems. We will then discuss trends that are starting to be introduced in AMR/AMI systems that provide more than just a meter read (i.e., pressure monitoring, leak detection, water quality monitoring, etc.). Lastly we will cover the importance of meter calibration and source meter testing, and go through the process, techniques, tools, and situations.
